I agree to adhere to the instructions and guidance of the club flight instructors and the Chief Pilot.

I also understand that I shall forfeit my privileges as a Member if aircraft are flown or operated by me, or are permitted to be flown or operated by me, either on the ground or in the air, in violation of Federal Aviation Regulations or Club Rules of Operation; and that any passengers carried while I am in command of Club aircraft shall at no time be at the Risk of the East Hill Flying Club, Inc. or any of the members thereof. And I agree to hold East Hill Flying Club, Inc. harmless from any claims arising therefrom.

I also agree to pay any and all club bills when due or forfeit my security deposit for the purpose of paying accounts due. Further, I authorize payment by the supplied credit card in the case of overdue amounts on my membership account.

I hereby authorize investigation without liability of all statements contained in this application, and I authorize any credit bureau to furnish you with a report concerning my credit.

NY State Notification of Insurance: As renter of aircraft, **you are insured under the East Hill Flying Club, Inc. policies of insurance**, providing liability insurance to members, as renters of aircraft, in the amount of \$1,000,000. You are insured for hull damage to the aircraft subject to a deductible of \$500, (or as determined by the Club's accident investigation in the case of violation of Federal Aviation Regulations.)

Although insurance may be provided for liability and/or hull coverage, the East Hill Flying Club, Inc.'s insurance carrier has no right to subrogate against you for any payments it may be required to make on account of any damage or loss arising out of your operation of the aircraft.
